- Report statics (approx. 3 month history)

 - 6 False alarms for home systems fines can be assessed

- NCC Trends:
 - Vehicle thefts lots of people leaving cars running to warm up
 - Dodge SUVs and larger vehicles are targeted more often
 - SUVs sitting for periods of time have been having catalytic converters cut off
- Stats are available on website for 7 day average

Representative Kim Williams Update:

- Thanked board and advised is currently in session
- Update on Roundabouts
 - o Old Capital Trail / Newport Rd & Old Capital Trail / Stanton Rd
 - Working on easements/purchase of 2 properties still
 - Projected possibly for 2025
- RR flashing lights on Stanton & Old Capital Trail RR company moves slowly to connect
- Senior Tax Credit
 - \circ 65 by July 1 and file by April 30
 - Contractor Registry approved
- Unemployment at 4.5%
- Troop 6 Demo & New building at new location
 - Community meeting at Dickenson School April 3 from 6-7 pm
- Polly Drummond Yard Waste opening March 26
- Recycle event August 12 @ Delcastle
- Currently working on legislation for:
 - Human trafficking legislation
 - Epi pen Bill for adults
 - o Drag Racing/Noise Level Bill
 - Pre-K Funding

- Short-term rental bill
- More traffic calming measures in the works after success of raised crosswalk
- Delmarva Rates
 - Has a public advocate that represents residents if bill is "out of whack"
 - Publicadvocate.delaware.gov 302-577-5077
 - o Is currently still in "Rates War"

Senator Spiros Mantzavinos Update:

- Trinity still on schedule for repaving DelDOT is behind
 - Speeding is an issue only street that does NOT have stop signs or speed bumps
 - Possibility of stop sign at Binstead intersection
- Trying to get more money for suburban roads with bond bills
- \$300 Rebate tax free fed and state
- Legislation:
 - Increase penalties on catalytic converter theft
 - Medical debt currently has 2 bill package
 - CCHS increased financial aid to 400x federal poverty level according to one resident
 Kim will send comparison website
 - Tax credit for veteran pension up to \$12,500 for below age 60
 - Caregiver tax credit introduced
 - Brew Pubs drive up/curbside service
 - Medical debt how being handled & researching
 - Capital project grants for NPOs with a 5/15/2022 deadline

- Bill Dunn: End of Redwood & Diamond where 3 new homes not up to code & based on 1930s surveys & data. The last section is approx. 6' narrower than state regulations
- Bernadette: Raised paving issues with cracking
 - Not graded and sealed correctly in summer 2022
 - Ponding water get locations to representatives to go back to DelDOT
- Tara: Backyard drainage issues with her and several neighbors due to construction staging area
 - Kim to check with conservation department
