Senator Spiros Mantzavinos

- Troop 6 on schedule to open 25Q1
- Sidewalk issues:
 - Need to narrow down when work was done (2018?)
 - o 3-year warranty
 - DelDOT is not involved due to utility work
- Speeding issues:
 - Still waiting on impact study
 - o Residents said the speed hump is too low
 - Still looking into other traffic calming measures
 - Waiting on ordinance to pass for speed cameras (Milltown & McKennon to test enforcement)
- Calf Run Park:
 - Concrete structures in the creek
 - Spiros asked for coordinates to check into
- Fenwick paving:
 - This will be completed using funds from Community Improvement Fund from both Spiros and Kim Williams

General Discussion

- Resident stated that blue paint marked on sidewalks on Trinity and possibly Henlopen. Sending locations to find out what paint is for.
- Residents voiced concerns over distractions, revenue, and privacy
- Resident voiced concern over neighbors parking on sidewalk on Fenwick. Has not reported to code enforcement

Representative Kim Williams Update:

- Sign update:
 - Will be funded, waiting on DelDOT to reach back out regarding next steps
- Community updates:
 - o Playground at Powell Ford Park has been installed
 - Kirkwood Hwy Acme is closing at end of November
 - o Kirkwood Hwy Redevelopment meeting on October 8
- Legislation updates:
 - Sponsored 40 bills, 31 signed
 - We are the 1st state to address food allergies

Councilman Brandon Toole

- Cpl. Will Dejesus is deployed until September 30
 - o Cpl. Dollard is new contact but is on desk duty due to a broken foot
- There will be a public safety night at Banning Park
 - o Pizza & water ice
 - o State Police & local Representatives
- Crime updates:
 - o General statistics
 - Assault is up 19% in last 2 years
 - Vehicle thefts are still targeting Hyundai and high end vehicles
 - Shootings/homicides are up: 4 since January
 - o Kiamensi updates
 - Stolen bike
 - Several resident welfare checks
 - Loud music complaints
 - Suicide/mental health episode
 - Land use has 4 active and 14 closed reports
- Hiring arborist to determine health of trees in Powell Ford and dead trees
- Reassessment update:
 - o Everyone should have gotten data mailer
 - o Tyler Technologies (302) 395-3620
- Fire Department Feasibility Study:
 - o Evaluated fire departments and how they spend funds
 - o Fire departments struggling to get volunteers
 - o Christiana FD has a \$4.5M Operating cost
 - \$2.1M to replace ladder truck
 - Looking into how able to start charging fire service tax

- Website updates:
 - o NCC property maintenance links and to report Delmarva street lights out
